The Legal Center actively supported HB11-1216 to create funding to assist people with disabilities in obtaining benefits through the sale of unique

license plates. The bill passed and was signed by the Governor.

The Legal Center actively supported HB11-1219 the Uniform Military and Overseas Voters Act which included provisions to establish an electronic transmission system for election materials, establish methods of registering to vote and applying for ballots, administer the delivery and receipt of ballots and the delivery of election notices. The bill passed and was signed by the Governor.

The Legal Center actively supported SB11-171 to establish a database to track substantiated allegations of mistreatment of at-risk adults by caregivers. The bill was postponed indefinitely.

The Legal Center actively supported SB11-049 which created a ban on the use of prone restraints in programs administered by the Colorado Department of Human Services. The legislation was postponed indefinitely but the intent was established through Executive Order in 2012.

The Legal Center actively supported SB11-183 which requires the appointment of a person with a disability or a family member of a person with a disability on the State Boards of Housing, Medical Services and Human Services. The bill passed and was signed by the Governor.
