# Hundreds Expected at Colorado Capitol for Disability Rights Advocacy Day 2026

Lt. Governor Primavera, State Representative Clifford, and Advocates to Rally for Change

**DENVER, CO** — On **Thursday, February 12, 2026**, people with disabilities, advocates, and policy leaders will gather at the **Colorado State Capitol** for **Disability Rights Advocacy Day (D-RAD 2026)** — a powerful day of civic engagement, storytelling, and calls for greater equity, access, and inclusion in Colorado law and public policy.

Hosted this year by the **Colorado Developmental Disabilities Council (CDDC)**, D-RAD is a grassroots-led advocacy event that empowers Coloradans with disabilities to share their lived experiences directly with elected officials and legislative staff.

## Event Schedule:

- **9:30–10:00 AM** – Check-in, welcome, and networking
- **10:00 AM–12:00 PM** – Legislative meetings and advocacy activities
- **12:30–2:00 PM** – Rally and speeches from elected leaders

Confirmed speakers include **Lieutenant Governor Dianne Primavera, State Representative Chad Clifford**, and other Colorado legislators. The program will be **emceed by former Representative and Disability Law Colorado Board Member David Ortiz**.

**D-RAD 2026** builds on last year's strong turnout and media attention, continuing its tradition as a unifying moment for the disability community and its allies.

- Self-advocates and people with disabilities
- Event organizers and policy experts
- Elected officials and community partners
